The purpose of the pilot project is to assess the creation, administration, and outcomes of a fund to support open access scholarly publishing opportunities for the purpose of heightened visibility and accessibility for University of Kansas research. The \$50,000 pilot project is funded jointly by the University of Kansas Provost, the University of Kansas Medical Center Executive Vice Chancellor, and the Offices of Research at The University of Kansas and University of Kansas Medical Center. Open Access Week at KU

I spoke Wednesday afternoon at <u>The University of Kansas</u> about H.R. 4004 - the <u>Federal Research Public Access Act</u>, or FRPAA, as part of a series of events and lectures marking October 22-28 as Open Access Week. I am an original cosponsor of the FRPAA bill and proud that KU is leading the effort on open access. FRPAA requires that research funded by federal agencies to be made available free of charge to the public, and is modeled after current requirements in place for research funded by the National Institutes of Health. Currently, most federally funded research is only published through journals that require subscrition fees. The University of Kansas Libraries are joining more than 100 countries around the world to highlight the importance of online access to scholarly research.


