STATE UNIVERSITY

LAWRENCE, KANSAS, April 30th, 1863.

TO HIS EXCELLENCY, THOS. CARNEY.

Governor of the State of Kansas:

We, the undersigned Commissioners, appointed by your Excellency, to select forty acres of land in or adjacent to the city of Lawrence, for the use of the State, as a suitable site on which to permanently locate the university buildings, beg leave to submit the following report:

We, the Commissioners, qualified within the time prescribed by statute, and placed our oaths of office on file with the Secretary of State, and agreed to meet at the Eldridge House, in the city of Lawrence, on the 16th day of March, A. D. 1863.

At such meeting, Prof. I. T. Goodnow and Josiah Miller, (being a majority of the Commissioners,) were present, and proceeded to examine the lands in or adjacent to the city of Lawrence. After spending several days in such examination, we adjourned. In the meantime, preliminary steps were taken by us, in our individual capacity, to get the best practicable site; after which, it was agreed that we meet on Wednesday, the 29th day of April, A. D. 1863.

At said meeting, all of the undersigned Commissioners were present, whereupon we proceeded to select forty acres of land, which we deem a very suitable site, situated in the county of Douglas and State of Kansas, described as follows: Beginning at a point on the north line of the northeast quarter of section one, township thirteen south, of range nineteen east of the sixth principal meridian, twenty rods west of the northeast corner of said quarter-section; running south, forty rods; thence west, seventy-one rods; thence north, one hundred and one rods and fifteen feet; thence south, thirty-nine

rods and nine feet thence east, twenty-one rods and one and a half feet; thence south twenty-two rods and six feet, to the place of beginning; being adjacent to the city of Lawrence, and more particularly described in the two deeds, conveying to the State, without cost, a "good and sifficient title in fee simple, with warrantee thereto," accompanying this report, and made a part thereof, marked "A" and "B," and also more readily understood by the accompanying plat of the ground, marked "C."

### PROCLAMATION OF THE GOVERNOR.

STATE OF JANSAS, EXECUTIVE DEPARMENT.

WHEREAS, The Commissioners appointed to pemanently locate the State University, did, on the first day of My, A. D. 1863, file in the office of the Auditor of State their report, locating said institution at an eligible point, adjacent to the City of Lawrence, and did file therewith a good and aufficient deed in fee simple, with warrantee thereto, to forty acres of land for the site of said institution; and,

WHEREAS, The Treasurer of State has certified that the sum of fifteen thousand dollars has been deposited with him as a fund for said University; and,

WHEREAS, The provisions of law governing the location of said University have been fully complied with;

Now, therefore, I, Thomas Carney, Governor of the State of Kansas, by virtue of the authority in me vested by law, do proclaim and declare the University of the State of Kansas to be permanently located at the city of Lawrence, upon the tract of land selected and deeded to the State of Kansas, as above set forth.
