## Submissions

### Articles:

*Indigenous Nations Studies Journal* uses a double blind review process. We require a hard copy of the manuscript and a copy on a 3 1/2" floppy disk or in an e-mail attachment in a PC compatible word processing format such as Microsoft Word. No formatting changes should be made to the file and an abstract of approximately 100 words must be included. Manuscripts cannot be returned. Contributors are asked not to put their names on the manuscript. Contributors agree upon submission that manuscripts submitted to *Indigenous Nations Studies Journal* shall not be submitted for publication elsewhere while under review by the *Indigenous Nations Studies Journal*. Articles should be 25-30 pages, double-spaced, using endnotes, and based on original work and primary research data. Please be sure that all notes and bibliographical data **are complete** before submittal.

### Book Reviews:

Books chosen for review must be approved by the *Indigenous Nations Studies Journal* Book Review Editor before submittal. Reviews should contain approximately 500-750 words, the reviewer's institutional affiliation and name, and be double-spaced. Reviews must be submitted on a 3 1/2" floppy disk or by e-mail attachment in a PC compatible word processing format such as Microsoft Word (a paper copy is also acceptable).

## Notes On Contributors

**Manley A. Begay, Jr.** is a citizen of the Navajo Nation. He earned his doctorate in Education at the Harvard Graduate School of Education, in Cambridge, Massachusetts. He is both director of the Native Nations Institute for Leadership, Management, and Policy in the Udall Center for Studies in Public Policy and senior lecturer/associate social scientist in the American Indian Studies Program at the University of Arizona. He is also co-director of the Harvard Project on American Indian Economic Development John F. Kennedy School of Government, Harvard University.

**Gregory Evans Dowd** earned his Ph.D. at Princeton University. He has taught at the University of Notre Dame, the University of Connecticut, the University of the Witwatersrand, and he now teaches in the Department of History and the Program in American Culture and coordinates Native American Studies at the University of Michigan, Ann Arbor. He is the author of *War under Heaven: Pontiac, the Indian Nations, and the British Empire* and *A Spirited Resistance: the Native American Struggle for Unity, 1745-1815*.

**Antonie Dvorakova** is working on a doctorate in Cultural Psychology at the University of Chicago. She holds a Master's Degree in Indigenous Nations Studies from the University of Kansas. She is also a former Fulbright exchange student.

**Bill Erasmus** was the National Chief, Dene Nation (1987-2003). He holds a BA from University of Alberta. The Erasmus family has been called one of the founding families, see North Slave Métis Alliance. The National Chief of the Dene Nation is the spokesperson for the Dene.

**Stephanie Irlbacher Fox** is currently Magdalene Donner Scholar in North American Studies at Magdalene College, Cambridge University, where she is completing a Ph.D. in Polar Studies. She continues to work as a resource person for Indigenous governments on self government negotiations in the NWT.

She is currently a research scientist at the Native American Research and Training Center within the Department of Family and Community Medicine in the College of Medicine at the University of Arizona. **Cornel Pewewardy** is an Associate Professor in Teaching and Leadership at the University of Kansas. He received his Doctorate of Education from Pennsylvania State University. He is the author of articles on American Indian education, educational policy and theory, critical pedagogy, and multicultural education.
