

Purchasing Deadlines Requiring Bidding

The Purchasing Office recently distributed a memo to all faculty and staff regarding FY04 purchasing deadlines for orders requiring the bid process (i.e. competitive orders of \$5,000 or more). All purchases to be chargeable against FY04 funds which require competitive bidding must be submitted to Denise Swartz at least one week in advance of the following dates to insure that the orders will be processed and submitted to the Purchasing Office by the required deadline dates.

- 1. Monday, May 3, 2004 if the amount is estimated to be \$50,000 or more
- 2. Monday, May 24, 2004 if the amount is estimated to be more that \$25,000, but less than \$50,000
- 3. Monday, May 31, 2004 if the amount is estimated to be less than \$25,000, but more than \$5,000

IF FR involves a trade-in, the due date is one week EARLIER than stated above.

Purchase requisitions chargeable against fiscal year 2005 funds may be submitted at any time, however, fiscal year 2004 transactions will be given priority.
