Kevin Bruyneel is a Ph.D. candidate in the Political Science Department at the New School for Social Research. In Spring 2001, he will complete a dissertation, entitled "Politics on the Boundaries: Indigenous People's Politics in the United States," that seeks to understand the historical and contemporary logic of indigenous people's political claims and activities in the U.S., with a comparative look at how such political logic works in Canada. He presently teaches classes at the New School and New York University.

Venida Chenault is a member of the Prairie Band Potawatomi and Kickapoo Nations. She is on the Social Science faculty at Haskell Indian Nations University and is currently pursuing a doctorate in Social Work at the University of Kansas. Ms. Chenault has served as Interim Director for American Indian Studies, as well as Associate Dean for the University. She is currently serving as the Chair of the Prairie Band Potawatomi Constitution Committee.

Dixie Ray Haggard is a doctoral candidate at the University of Kansas, completing a dissertation titled "From Green Corn to Cotton: Culture and Environment in Cherokee and Muscogulge Identity Persistence." His research focus is on the Indigenous Southeast and Continental Colonial North America. He received his Bachelor's and Master's in history from Georgia Southern University and is currently adjunct faculty at Haskell Indian Nations University, teaching Western Civilizations I, and teaching Early U.S. History at the University of Kansas.

Rauna Kuokkanen is a Sami scholar currently at the University of British Columbia, Vancouver. Her work deals with questions of indigenous paradigm, epistemologies and decolonization of research from an indigenous (and/or Sami) point of view. Her approach to these issues is through indigenous peoples' literatures, which are the sources of central cultural metaphors. Previously she had been involved in Sami politics both at the local and international levels.

Sharon O'Brien is an Associate Professor in Political Science and Indigenous Nations Studies. She obtained her Ph.D. at Oregon, concentrating on Federal Indian Law, Tribal Governments, and International Law. Her publications include *American Indian Tribal Governments* and several articles in law journals on the status and rights of indigenous peoples. She is completing a book on American Indian religious rights.
