# **Executive Summary**

#### **PERSONNEL**

Rebecca Brown resigned as Kansas/Technology Coordinator effective August 5, 2011 to assume a trainer position for the NLM Training Center. She has been with the RML since January 31, 2007.

Siobhan Champ-Blackwell, Health Information Literacy Coordinator, resigned her position effective August 31, 2011. She will begin working for Aquilent, a contractor for NLM's Disaster Information Management Research Center. Ms. Champ-Blackwell began with the RML on October 15, 2002.

Sandy Drollinger, Financial Analyst, resigned effective October 14, 2011. She accepted a position in the medical school that would be a promotion. Ms. Drollinger had been with the RML since August 4, 2008.

Recruitment ensued in Salt Lake City for the Utah/Member Services Coordinator and the Financial Analyst positions. Recruitment ensued at Creighton University Health Sciences Library and A.R. Dykes Library for the Health Information Literacy and Kansas/Technology Coordinator positions.

Lin Chen accepted the position as Financial Analyst and started on October 31, 2011.

Recruitment was not successful for the Utah/Member Services Coordinator.

Recruitment continues for the positions at the Resource Libraries.

Claire Hamasu, Associate Director, traveled to Pittsburgh and shared her RML experiences with the NN/LM Middle Atlantic staff. It was exciting to be part of a brand-new RML, even for two days.

### **EDUCATION**

Marty Magee, Nebraska/Education Coordinator, chaired MCMLA Education Committee meetings throughout the quarter in preparation of CE offerings at the chapter's annual meeting. The committee served as the education workgroup. Classes and sessions were tied to the RML's objectives in assessment and evaluation, emergency preparedness, library advocacy, and technology. The NLM Training Center offered PubMed and ToxNet classes.

### LIBRARY ADVOCACY

One of our members in Missouri was reported to be using our membership requirements in order to increase library resources.

Jim Honour, Wyoming Coordinator, consulted with the librarian at Wyoming Medical Center. She has been in touch with RML coordinators for a while about changes affecting the library. She requested that MLA and MCMLA write to her administration in support of the library. Unfortunately, the administrator did not appreciate receiving the letters from outside agencies and has reduced the position to half-time and limited the librarian's responsibilities to ILL and licensing electronic resources. This is an example of how delicate the situation may be when we try to support Network members.

Letters were sent to the VA Rocky Mountain Network VISN 19 to encourage filling two open positions, in Denver and Cheyenne. Letters were sent to Exempla Lutheran Medical Center and Swedish Hospital in Denver following the firing of their librarians. No response was received.

Ms. Hamasu invited the Utah Congressional delegation to visit the library for a presentation on the NN/LM. During August, September and October representatives from all the offices were introduced to the NLM, the NN/LM, and the NLM Training Center by Jean Shipman, Director; Ms. Hamasu; and Sharon Dennis, Assistant Director of the NLM Training Center. NLM provided many of the handouts that were included in a packet. Staff expressed their appreciation for the invitation. We even had one Congressman, Jim Matheson, visit with us. No one except Representative Matheson, (his wife is a physician) was aware of NLM and the NN/LM so at a minimum, we raised awareness among Utah's congressional staff.

#### **HEALTH INFORMATION LITERACY**

Dana Abbey, Colorado/Health Information
Literacy Coordinator, and Ms. Champ-Blackwell
met with members of the collaborations work
group to review the work MCR is doing with
state libraries. The work group thought this was
an appropriate role for the RML since Network
members would more likely work with local
public librarians than someone at the state
level.

Ms. Magee continued to work with public health professionals and colleagues from the McGoogan Library of Medicine to establish Health Literacy Nebraska. They are focusing on funding and promotional efforts. They will

present a poster at the Public Health Association of Nebraska's annual meeting and create a web site.

Mr. Honour announced two funding opportunities to the region. One is the continuation of our professional development scholarships. Network members can apply for funding to attend workshops, conferences, any event that will increase their skills or knowledge. In return they must share what they learn with the region. With Ms. Abbey, he developed the promotion to encourage members to exhibit and present at health professional meetings. The RML will cover the cost of working at the conference.

John Bramble, Technology Coordinator, prepared instructions for staff to follow up with members who did not renew their membership. Ms. Abbey and Ms. Hamasu completed contacting their assigned members.

Mr. Bramble launched the campaign for members to update their serial holdings and institutional records. By the end of October, there were only three members who had not updated their records in the last year. All members with current records will receive an MCR designed Tugger pin.

#### **Resource Libraries**

Anticipating a flat or reduced budget for year 2, Ms. Hamasu and Ms. Shipman worked up several staffing models for the MCR. They met with the Resource Library Directors and coordinators to review and discuss the models. The model reducing Utah staffing by 1 FTE and moving member services responsibilities to Wyoming was clearly preferred.

Resource Library Directors meeting: Ms.

Shipman and Ms. Hamasu facilitated a meeting of the Resource Library Directors. Mr. Bramble presented a review of the year 1 Technology logic model and Mr. Honour described the funding available to Network members.

Directors were asked about MedPrint. Although some will consider participating others thought that the period of commitment was too long and others had incomplete issues and were not eligible.

Dykes Library will lead an exchange program among Resource Libraries within driving distance to support sharing expertise among staff. If the exchange is successful, Ms. Shipman and Ms. Hamasu indicated they would be willing to have the RML expand it to the region.

## **TECHNOLOGY**

Staff reviewed and discussed Google Analytics usage statistics for 2008-2009 (year 3) and 2009-2010 (year 4). A surprisingly low volume of visits came from the MCR states. Staff decided to weed the web site of pages that few members were using. Mr. Bramble, Ms. Champ-Blackwell and Ms. Abbey volunteered to develop a plan to weed the web site. Instructions were sent out in October. Weeding is complete for two tabs, Health Information and Promoting Libraries & Librarianship.

# **Evidence Based Health:**

Mr. Bramble asked Donna Kafel, at University of Massachusetts Lamar Soutter Library, if the NN/LM could link to the e-science page she developed for the New England Region. Javier Crespo, Associate Director for the NN/LM NER, agreed that rather than having every region redoing the page, the nnlm.gov site could link to what has already been developed.

Ms. Magee sent out information on the structured evidence queries for Healthy People 2020 objectives to academic librarians who support public health programs.

Barb Jones, Missouri/Library Advocacy Coordinator, met with co-authors to outline the chapter they will be writing for a book on patient safety scheduled to be published in 2012.

The MCR decided to collaborate with the Spencer S. Eccles Health Sciences Library to plan for the 2012 Priscilla Mayden Lecture. The topic is e-science and the MCR will arrange for a CE class on data curation and management for

health sciences librarians and fund experts to be part of a panel reacting to the keynote address. The event will be held on February 22, 2011 and all members will be invited. The lecture and panel discussion will be broadcast. The MCR will hold a discussion webinar a week later for anyone who attended the day inperson or virtually to provide comments and discuss issues that were raised.

# Assessment and evaluation activities/data:

Betsy Kelly, Assessment and Evaluation Coordinator, facilitated the staff discussion on implications of the 2010 focus group report and action items that the MCR should take in response. The action items were added to the focus group report and the final report was attached to the NN/LM MCR's 2010-2011 Annual Report.

For its session at the chapter meeting the MCR played a baseball game with members where they were asked to vote on activities and initiatives the RML had planned. Using clickers

they could indicate whether they thought we hit from a home run to a foul ball. As everyone got into the game the percentage of home runs increased. Not a reliable feedback mechanism, but everyone seemed to have fun.

WebSTOC and OERC requested that each RML assess user needs and feedback on regional web sites. Ms. Hamasu compiled data from the 2008 Network Member Questionnaire, Google Analytics for 2008 and 2009, questionnaires distributed in years 4 and 5, and the communication audit. This report was sent to OERC.

NNO requested feedback on an idea from the BOR Outreach Subcommittee to focus outreach on benefits managers. Following a discussion MCR staff responded that this was a feasible group to contact. Benefit managers are usually part of human resources departments and have no health background. They may appreciate learning about MedlinePlus and other resources they could promote to their employees.

Ms. Abbey was encouraged to speak to the program head about NLM resources and then pull in the community college librarian. Ms. Magee contacted the librarian at Metropolitan Community College who also is

not involved in supporting the HIT curriculum. Ms. Magee, too, was forwarded on to the HIT department head who reported that they are already promoting MedlinePlus in their classes. She was willing check with faculty about receiving additional training and resources from Ms. Magee.

Ms. Abbey monitors the Health Educators Association listservs for educators who work with patients and other health care staff. She responded to a query regarding patient information and meaningful use and promoted MedlinePlus Connect.
