11) Project Summary: The Creighton University Health Sciences Library will partner with Project Interfaith and the Respite Resource Center to promote awareness of religious diversity its effect on healthcare and to provide access to resources needed by healthcare workers. Using a workshop format, we will conduct training on religious diversity and how it can affect the way caregivers provide care. Through a day-long training seminar participants will reflect on their own religious views and learn about the religious views and beliefs of others in our diverse community. They will learn about accommodating the beliefs of others under the law, and about communicating in a sensitive manner. Participants will learn about how to access reliable health information and will develop best practices they can use in the community. They will be introduced to a website that will provide them with health information and religious diversity resources.

12) Evidence of need: The population of the United States continues to diversify religiously and religion is central to how many individuals understand themselves, their role in the world, and concepts of health, death, and dying. Douglas, Sarpy and Lancaster counties include the Lincoln and Omaha metro areas of Nebraska. According to data from the Religious Congregations and Membership (Glenmary Research Council, 2000), there are 62 different religious groups in those counties. Feedback from professional care givers working in long-term facilities, hospitals and in-home care agencies revealed that issues of religion and religious diversity often are inadequately addressed or are completely neglected in the broad cultural competency training many professional care givers and health care professionals receive. Professional care givers need to be equipped with the knowledge and skills to effectively work with and serve religiously-diverse populations.

13) Detailed Project Description: In 2007, Project Interfaith created the workshop “Religious Diversity Issues in Professional Caregiving”. In August, twenty-six care providers participated in this day-long training that provided useful information concerning religious diversity and its impact on their interactions with clients. This project will expand on the scope of the training to include identifying health information resources and provide a tool for accessing that information. We will conduct two trainings on religious diversity issues in care giving. This day-long training seminar will provide useful information concerning religious diversity and health issues to individuals and representatives from agencies and facilities providing care for people of any age with special needs and chronic conditions. The target audience includes professional caregivers, as well as volunteers and family caregivers with an emphasis on respite care providers. Nurses, certified nurse assistants, social workers, activity directors, health administrators, students, and other medical personnel are all encouraged to attend. The program includes presentation, exercises and discussions on identity and religion, developing a common language for discussing religious diversity issues, accommodating clients’ religious needs and practices under the law, an overview of basic beliefs and religious demographics of the major religious communities, a discussion on best practices, and how to find reliable health information resources. We will create a website that will provide participants with links to valuable health information resources as well as religious diversity information. We will promote the use

of these products and services by providing access to a laptop computer in the office of Project Interfaith, as well as access during the training sessions.

The first training is planned for August 2008 at the Heritage Pointe Assisted Living and Memory Support center in Omaha. A second training session will be held in 2009.

14) List specific project objectives you hope to achieve: By participating in this training, participants will:

- Explore their own views about religion and identity and understand how these views may impact their interactions with the clients, clients' families, and colleagues;
- Examine current and possible legal issues related to religious diversity in the health care profession;
- Gain knowledge of the basic beliefs, demographics and organization of the major religious communities locally and nationally;
- Locate and identify credible health information resources;
- Identify credible resources for increasing their knowledge about religious diversity, tools for assessing clients' spiritual and religious needs, and best practices for dealing with religious diversity in a care giving context;
- Identify strategies for incorporating information and knowledge gained through this training into their daily work and practices.
- Understand why an awareness of and sensitivity to the religious diversity of their clients enables them to be better health care providers and supports professional standards.

15) Describe how you will sustain these objectives beyond the funding calendar:

We will create a website that will be hosted either by Project Interfaith or Creighton University Health Sciences Library (or both) that will provide valuable links to health information as well as religious and cultural diversity resources. We will purchase a laptop with wireless internet capabilities that will be available at the Project Interfaith office for accessing the website and other health related resources. The laptop will also be used at the training sessions along with print resources at a display table.

Project Interfaith will continue to offer additional training sessions to the Omaha area with the possibility of expanding to other areas of Nebraska.

16) List the numbers and types of people you expect the project to reach: This project will involve two trainings on religious diversity issues in care giving. Each training can accommodate up to 50 participants and is open to professional care givers, medical personnel, and social service providers working in facilities and in-home care. Four full scholarships, designated for certified nursing assistants (CNAs) or students in the previously mentioned professions, will be awarded for each training. CNAs are many times the main caregivers of the chronically ill and yet have lower salaries, so a full scholarship will make it more affordable for them to attend training.

17) Methodology with specific steps: The goal of this project is to improve access to useful information concerning religious diversity and health care issues to individuals and representatives from agencies and facilities providing care for people of any age with special needs and chronic conditions, and that this information will be incorporated into the daily work and practices of participants.

We will create a website that will include program information, links to reliable health information resources, and links to resources for increasing knowledge about religious diversity. Access to this website and other information will be made available in part through a laptop workstation provided to Project Interfaith.

We will conduct two, day-long training sessions during the award period. The objectives and activities of the training sessions will be as follows:

Objective 1: Participants will explore their view about religion and identity and understand how these views may impact their interactions with clients, clients' families and colleagues.

Activity 1: The instructor will lead participants through identity exercises that focus on their own views of religion and will direct discussion on how this can impact interactions.

Objective 2: Participants will examine current and possible legal issues related to religious diversity in the health care professions.

Activity 2: A legal expert will provide information on the First Amendment and its implications for religious diversity issues in care giving and will discuss how to accommodate clients' religious needs and practices under the law.

Objective 3: Participants will gain knowledge of the basic beliefs, demographics and organization of the major religious communities locally and nationally.

Activity 3: Representatives from 6 different religions will present an overview of their basic beliefs and small group discussions will be held.

Objective 4: Participants will be able to locate and identify credible health information resources.

Activity 4: A health sciences librarian will present information on how to locate reliable health resources. The librarian will also provide handouts or guides to retrieving this information and will introduce participants to the website.

Objective 5: Participants will identify credible resources on increasing their knowledge about religious diversity, tools for assessing clients' spiritual and religious needs, and develop best practices for dealing with religious diversity in a care giving context.

Activity 5: The program director will present resources on religious diversity and identify assessment tools, directing participants to resources available through the website. The director will also lead a discussion on and help participants develop best practices.

Objective 6: Participants will identify strategies for incorporating information and knowledge gained through this training into their daily work and practices.

Activity 6: The instructor will present information on developing a common language to help participants discuss religious diversity issues and discuss strategies for incorporating best practices into their daily work.

Objective 7: Participants will gain an understanding of why an awareness of and sensitivity to the religious diversity of their client enables them to be better health care providers and supports professional standards.

Activity 7: The instructors and panel members will lead discussion on how awareness and sensitivity to religious beliefs can be a benefit to their clients.

19) State how you will publicize and promote your project to the target audience: The Respite Resource Center (RRC) will mail publicity and registration materials to their bulk mailing list of 780 in-home agencies, care giving facilities, day service centers and day cares as well as to their mailing list of 230 independent providers. RRC also will distribute these materials via e-mail to 500 care giving providers in the rural and urban area that offer services to people with disabilities. Project Interfaith will distribute publicity and registration materials via email to its distribution list of over 350 individuals. The Creighton University Health Sciences Library will distribute information to the Midcontinental Chapter of the Medical Library Association (MCMLA) members, the ICON Health Information Consortium members, and the Creighton University Medical Center associates. RRC, Project Interfaith and Creighton University Health Sciences Library will advertise these trainings on their websites. Activity 1: The instructor will lead participants through identity exercises that focus on their own views of religion and will direct discussion on how this can impact interactions.

Objective 2: Participants will examine current and possible legal issues related to religious diversity in the health care professions.

Activity 2: A legal expert will provide information on the First Amendment and its implications for religious diversity issues in care giving and will discuss how to accommodate clients' religious needs and practices under the law.

Objective 3: Participants will gain knowledge of the basic beliefs, demographics and organization of the major religious communities locally and nationally.

Activity 3: Representatives from 6 different religions will present an overview of their basic beliefs and small group discussions will be held.

Objective 4: Participants will be able to locate and identify credible health information resources.

Activity 4: A health sciences librarian will present information on how to locate reliable health resources. The librarian will also provide handouts or guides to retrieving this information and will introduce participants to the website.

Objective 5: Participants will identify credible resources on increasing their knowledge about religious diversity, tools for assessing clients' spiritual and religious needs, and develop best practices for dealing with religious diversity in a care giving context.

Activity 5: The program director will present resources on religious diversity and identify assessment tools, directing participants to resources available through the website. The director will also lead a discussion on and help participants develop best practices.

Objective 6: Participants will identify strategies for incorporating information and knowledge gained through this training into their daily work and practices.

Activity 6: The instructor will present information on developing a common language to help participants discuss religious diversity issues and discuss strategies for incorporating best practices into their daily work.

Objective 7: Participants will gain an understanding of why an awareness of and sensitivity to the religious diversity of their client enables them to be better health care providers and supports professional standards.

Activity 7: The instructors and panel members will lead discussion on how awareness and sensitivity to religious beliefs can be a benefit to their clients.

RRC also will distribute these materials via e-mail to 500 care giving providers in the rural and urban area that offer services to people with disabilities. Project Interfaith will distribute publicity and registration materials via email to its distribution list of over 350 individuals.
