Articles:

Indigenous Nations Studies Journal uses a double blind review process. We require two (2) copies of the manuscript, at least one in a pc compatible word-processing format on a 3 1/2" floppy including a 100-word abstract. Manuscripts cannot be returned. Contributors are asked not to put their names on the manuscript. Contributors agree upon submission that manuscripts submitted to *Indigenous Nations Studies Journal* shall not be submitted for publication elsewhere while under review by *Indigenous Nations Studies Journal*. Articles should be 25-30 pages, double-spaced, using endnotes and based on original work and primary research data. Please be sure that all notes and bibliographical data are **complete** before submittal.

Book Reviews:

Guidelines for book reviews: books chosen for review should be approved by the Indigenous Nations Studies office before submittal. Reviews should contain approximately 500 words and also be double-spaced. Reviews should be submitted in three formats: a pc-compatible word-processing format on a 3 1/2" floppy, or e-mail attachment and on a paper copy.
